### **SAFETY RULES**

To use a Segway, the participant must be at least 14 years old.

Please enquire before the start of a drive, which areas you are allowed to use with a Segway. Especially when renting, a written permission of the hirer must be available when driving on public roads. In any case, please read it before the start of a drive.

The minimum weight for the driver is 45kg. The maximum weight is 118kg additional load included.

You must have watched the Segway safety DVD at least or participated in a Segway safety instruction.

A helmet is required during each trip despite of the nonexistent legal obligation.

Be sure to obtain comprehensive advice in the handling of the Segway.

#### Important:

- 1. Functionality of the Segway and explanation of the infokey
- 2. Stepping on and off, accelerating, slowing down and steering left and right
- 3. Perception and attention of the warning signals of the Segway. When the LEDs are flashing red and the platform is vibrating, you must immediately interrupt the drive and leave the vehicle. When ignoring these signs, a safety shutdown may occur.

Don't step off the Segway during a drive and keep both feet on the platform. The pressure sensors must constantly be weight.

It is not allowed to take pictures or make a film during the drive. Important: keep both hands on the handlebar during the drive. Don't drive freehand! The only exception is to give hand signals indicating a process of turning left or right.

Only walking pace is allowed during a test drive or a course. A distance of at least 3 meters to the person in front must be kept. A distance of at least one meter on each side must be kept to all objects and persons or other Segway drivers. Please pay special attention to road damage and uneven ground. Please do not drive through puddles and potholes; beware of pavement edges and other obstacles. Please do not try to drive over them. In case of doubt, get off and pull the Segway over them (as shown in the safety instruction).

The Segway is approved for one person only. In no case take other persons or even children with you.

The instructions of the operator or the hirer and/or personnel must be followed. A disregard of the instructions can lead to a termination of the drive. In this case no reimbursement of a participation or rental fee occurs. The same applies, if influence of alcohol or drugs is suspected. Passing on of the Segways to third parties is excluded. (exception: rent, §4 rental agreement)

### LIABILITY EXCLUSION DECLARATION

Using the Segways, entering the course or test track and staying there as well as participating in all activities, is at your own risk.

Driving a Segway as well as driving a course or participating in a tour and staying there is only allowed to those, who have taken notice of and signed these safety rules and this liability exclusion declaration.

The operator/hirer assumes no liability for damages resulting in particular from operating Segways, unless the damages have been caused grossly negligent or intentionally by the operator/hirer or his employees. The liability exclusion declaration does not apply to damages from injury to life, body or health as well as for damages from breach of cardinal duties provided and insofar as the damages have been caused by the operator/hirer or his employees. Each user of the Segways is responsible for the civil and criminal liability for personal injury, property damage and financial losses caused by him or the driven vehicle.

Using a Segway is not allowed to persons, who suffer from physical deficiencies, or who are under the influence of alcohol, drugs or medication. Pregnant women or persons who suffer from heart problems or high blood pressure are strongly advised not to use a Segway.

For companies, liability resulting from a slightly negligent breach of cardinal duties is also excluded. Also liability for third parties is excluded. Driving the Segway model x2 or XT is only allowed on private property with the permission of the owner. At the moment, the Segway x2 is authorized for use on public roads in Bavaria only. The registration law for tours with the Segway i2 on public roads, is to be taken note of. Special attention has to be paid to the authorized areas, before the start of the trip.

When using the SEGWAY vehicles, the instructions of the operator/renter must be followed. The operator/landlord assumes no liability for damage caused by his own fault or that of a third party, as a result of an accident or improper treatment, or because the instructions of the operator/landlord or their employees are not followed, and the user will be charged a maximum of €500. - be invoiced.
